- The qualified and eligible candidates of AP LAWCET/PG LAWCET-2025 are informed to register and participate for APLAWCET/PGLAWCET-2025 Web Counseling for admission in to the First Year of 3 Year and 5 Year LLB/LLM Courses for the Academic Year 2025-2026 as per the timeline given as under.
- The details of colleges, courses, seats & tuition fee and all other important information are placed on the Website https://cets.apsche.ap.gov.in
- The Candidates are informed to visit this website before Registration and Web
 options. Candidates are informed to upload their certificates for verification at
 https://cets.apsche.ap.gov.in
- Candidates are informed that they should satisfy the eligibility criteria for admission under BCI Rules and related State G.Os and should be prepared to pay the tuition fee and other fee as applicable.
- This Notification itself is a call for counseling. No separate call letters will be sent to the individual candidates.
- Mere attending web counseling does not guarantee a seat.
- The Candidates already registered and verified in the first phase can directly opt for web options. No separate registration is required for final phase.
- The Qualified and eligible candidates seeking admission are informed that the Final phase web counseling process will be as per the following schedule

I. Payment Procedure

- The registration process requires payment of a non-refundable processing fee
- Rs.500 for SC/ST/PH candidates and Rs.1000 for others.
- Payment must be made online through the Bill Desk gateway available at https://cets.apsche.ap.gov.in
- The Candidate has to enter their hall ticket number and rank/date of birth and click on pay.
- Accepted modes of payment include credit card, debit card, net banking, and other available channels.
- Once the payment is success, save or print the receipt
- The Candidate shall note that he/she shall have paid the processing fee when candidate upload scanned copies of certificates i.e., the processing fee should be paid online by the candidate before he/she upload scanned copies of certificates.

II. Online certificate Verification

- a. Verification of Certificates of all candidates will be done online.
- b. The following are the scanned original certificates to be uploaded at the time of Registration. Scanned original certificates issued by the respective universities only will be considered. Certificates downloaded from websites will not be considered.
- 1. AP LAWCET/ PG LAWCET-2025 Hall Ticket
- 2. AP LAWCET/ PG LAWCET-2025 Rank Card
- 3. Transfer Certificate (T.C.)
- 4. Degree Marks Memos or Consolidated Marks Memo
- 5. Original Degree or Provisional Certificate
- 6. Intermediate or Equivalent Marks Memo
- 7. S.S.C. or its equivalent Marks Memo
- 8. Study Certificates of previous Seven years of study from the first appearance of the qualifying exam.
- 9. Residence Certificate (in case where candidate has no institutionalized education) in respect of Private candidates of A.P. State.
- 10. In respect of Non-Local Candidates, Residence certificate of either of the parent in A.P. for a period 10 years excluding the period of employment outside Andhra

- Pradesh duly signed from the Tahsildar / MROs only.
- 11. Latest valid Income Certificate issued by the competent authority containing the name of the candidate
- 12. Caste Certificate issued by competent authority in respect of SC/ST/BC (for "SC" Category, caste certificate should be taken on or after 19.04.2025 from competent authority clearly stating caste as per G.O. Ms. No.7 Social Welfare (CV) Department, Govt. of Andhra Pradesh, dated: 18.04.2025)
- 13. Minority Certificate (SSC TC containing Minority Status or Certificate from the Head Master).
- 14. Latest Economically Weaker Section (EWS) certificate 2025-26 (if applicable)

NOTE

- 1. Eligibility for Admission into year LLB course: 10+2+3 (Regular/Distance Method) from any recognized university of India or outside or equivalent.
- 2. Eligibility for Admission into 5-year LLB course: 10+2 or equivalent.
- 3. The applicants who have obtained 10+2 or graduation /post-graduation directly through Open Universities system without having any basic qualification for such studies are not eligible for admission into law courses.
- 4. Mere allotment of a seat through the admission counseling will not guarantee the admission to the candidate unless she/he satisfies the eligibility criteria for admission as per the Bar Council of India Rules notified time to time.
- 5. Candidates who are allotted seats in a particular college shall submit original certificates in the college for physical verification.
- 6. The Principal of the concerned college shall also be responsible for verification of

the eligibility of the candidate for admission.

7. Tuition fee, if payable shall be paid by the candidate at the college.

8. The candidates should make sure that the certificates and other required documents

are clearly scanned and are uploaded properly as improper uploads may lead to

rejection. Kindly check your application status after uploading all the requisite

documents.

9. Candidates who studied the qualifying examination in Distance/ Private /

Correspondence mode as per BCI Rules are not eligible to study 3 Year and 5 Year

Law courses. However, they may join the courses at their own risk by submitting

the prescribed undertaking on Rs. 20/- stamp paper at the college.
